ORDER NUNC PRO TUNC CORRECTING ORDER OF DISTRIBUTION
AND DISCHARGE.

The above entitled matter coming on to be heard before me, the undersigned Judge of said Court, on this 17th day of August, 1922, and there being presented in open Court the application of said J. R. Burnside for an order nunc pro tunc herein, correcting the description of the real property, wherever recited in the Order of Distribution and Discharge filed herein on the 20th day of November, 1919, to Block 122.
