That mrt of the Southeast quarter (SE4) of the Southeast Quarter (SE_4^1) lying west of the Midland Valley Railroad Right of Way of Section Thirty-six (36), Township Twenty-one (21) North, Range Twelve (12) East, containing 17.89 acres more or less, Tulsa County, Oklahoma,

That by reason of his being enrolled as full blood citizen of the said Cherokee Nation, the said land above described was restricted until his restrictions thereon were removed; that his restrictions on his said land above described were not removed until May 16th, 1922; that a true and correct copy of said order of removal has been duly recorded in the office of the County Clerk within and for Tulsa County, State of Oklahoma; your afficint has been informed and states the facts to be that his allotment above described has been assessed for taxes for the years of 1908 to 1921 inclusive; that said assessment is erroneous for the reason that the said land was restricted during said period, and the restrictions had not been removed thereon.
