HAVE GRANTED? SOLD AND CONVEYED and by these presents do GRANT, SELL AND CONVEY UNTO THE SAID J. M. Berry of the County of Tulsa, State of Oklahoma all that certain piece, parcel or tract of land lying and being situated in Tulsa County, Oklahoma and being lot # 13, in Roselawn Section, containing 759 square feet, be the same more or less out of ROSE HILL BURIAL PARK as more fully appears from map of said Burial Park hereby referred to and made a part hereof.
