Also 25 shares of stock of said Association, Certificate No. 917 Class BThis mortgage is given in consideration of Twenty-five hundred Dollars, the receipt of which is hereby acknowledged,  
and for the purpose of securing payment of the monthly sum, fines and other items hereinafter specified, and the performance of the covenants hereinafter contained.And the said mortgagor for themselves and for their heirs, executors and administrators, hereby covenant with said mortgagee, its  
successors and assigns, as follows:FIRST. Said mortgagor S. being the owner of 25 shares of stock of the said UNITED SAVINGS & LOAN ASSOCIATION, and having  
borrowed of said Association, in pursuance of its by-laws, the money secured by this mortgage, will do all things which the by-laws of said Association require share-

with insurers approved by the mortgagee in the sum of Twenty-five hundred dollars, as a further security to said mortgage  
debt, and assign and deliver to the mortgagee all insurance upon said property.FOURTH. If said mortgagor S. make default in the payment of any of the aforesaid taxes or assessments, or in procuring and maintaining insurance as above  
covenanted, said mortgagee, its successors or assigns may pay such taxes, effect such insurance, pay said liens, and the sums so paid shall be further lien on said premises  
under this mortgage, payable forthwith, with interest at the rate of ten per cent per annum.FIFTH. Should default be made in the payment of said monthly sums, or any of said fines, or taxes, or insurance premiums, or any part thereof, when the same  
are payable as provided in this mortgage and in said note and said by-laws, and should the sum, or any part thereof remain unpaid for the period of  
three months, then the aforesaid principal sum of Twenty-five hundred DOLLARS,  
with arrearages thereon, and all penalties, taxes and insurance premiums, shall, at the option of said mortgagee, or of its successors or assigns, become payable immediat-  
ly thereafter, anything hereinbefore contained to the contrary thereof notwithstanding. In the event of legal proceedings to foreclose this mortgage, the indebtedness  
thereby secured shall bear interest from the filing of such foreclosure proceedings at the rate of ten per cent per annum in lieu of the further payments of monthly install-  
ments.SIXTH. The said mortgagors shall pay to the said mortgagee or to its successors or assigns, the sum of Two hundred & fifty DOLLARS,  
as a reasonable attorney's fee in addition to all other legal costs, as often as any legal proceedings are taken to foreclose this mortgage for default in any of its covenants,  
or as often as the said mortgagors or mortgagees may be made defendant in any suit affecting the title of said property, which sum shall be an additional lien on said
