Boecker all single man to said Association to secure a loan ofFifteen Hundred and no/100 DOLLARS, and the sum ofEleven and 93/100 DOLLARS; the same being the interestdue monthly upon said sum so borrowed by us And we promise to pay said Association at its Home Office at Tulsa Oklahomathe said sums of money, amounting in the aggregate to Twenty-one and 90/100 DOLLARS;on the 15th day of each and every month, and continue such monthly payments for a term of 106 months from the date hereof.
