NO. 208113 NRS RELEASE OF MORTGAGE.

COMPARED WHEREAS, Frances C. Mayhew, a widow, of Tulsa, State of Oklahoma, as Mortgagor, did on the 25th. day of August, 1920, execute a certain mortgage recorded on the 25th. day of August, 1920, in the office of the County Clerk, Ex Officio Register of Deeds, of Tulsa County, State of Oklahoma, in Book 305, at page 598, to Exchange Trust Company, a corporation, of Tulsa, Oklahoma, Mortgagee, upon the following described real estate situated in Tulsa County, State of Oklahoma, to-wit:
