

## PARTIAL RELEASE OF JUDGMENT.

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, on the 11th day of October, 1921, a judgment was rendered in the above entitled cause, in favor of the plaintiff and against the defendants, foreclosing certain mortgages executed by Woodson E. Norvell and Norma L. Norvell in favor of the plaintiff, Nola Childers Tracy, and

WHEREAS: among other mortgages so foreclosed was a mortgage executed on January 21, 1919, recorded in Book 261, page 27, in the office of the County Clerk within and for Tulsa County, Oklahoma covering and describing among other property

The North 100 feet off the Lot Numbered Five (5) in Block  
Five (5) in Horsley Hill Addition to the city of Tulsa,  
as shown by the recorded plat thereof, and

WHEREAS, the above named defendants have this day paid the full amount claimed to be due upon the indebtedness secured by said mortgage,

Now therefore, the above named plaintiff acknowledges satisfaction in full of the amount claimed to be due upon the indebtedness secured by said mortgage, including interest and attorney fees, and does hereby release the lien of said judgment insofar as it covers the said North 100 feet off the lot Numbered Five (5) in Block five (5) of said Horsley Hill Addition to the city of Tulsa.

and in consideration of the payment of said judgment only insofar as same covers said North 100 feet of said Lot Five (5), and the partial release of said judgment it is agreed by and between the parties above named, that said payment and release shall in no wise affect the appeal taken by the plaintiff herein from the said judgment, except that upon a final determination of the action, there shall be credited upon such judgment as may be rendered in favor of the plaintiffs, the sum of Fifteen Hundred dollars, (\$1500.00) upon which such judgment shall be foreclosed to satisfy the balance of said judgment as to all of the property described therein except the said North 100 feet off said Lot Five (5)
