206280 C.M.J. **COMPARED** ASSIGNMENT OF OIL AND GAS LEASES.

WHEREAS, the undersigned, ALF G. HEGGEM and M. E. DAVIS, of Tulsa, Oklahoma, are the owners, as assignees, of the oil and gas mining leases hereinafter described, and desire to sell, transfer and assign the same, together with all rights, privileges and property connected therewith,

NOW, THEREFORE, For and in consideration of the sum of One (\$1.00) Dollar, and other good and valuable considerations, the receipt of which is hereby acknowledged, the said Alf G. Heggem and M. E. Davis do hereby bargain, sell, transfer, assign and convey to E. A. BRADLEY, of Tulsa, Oklahoma, his heirs, administrators and assigns, and undivided three-eighths interest to ANNIE BRADLEY, of Tulsa, Oklahoma, her heirs, administrators and assigns, an undivided three-eighths interest, and to A. E. BRADLEY, of Sapulpa, Oklahoma, his heirs, administrators and assigns, an undivided two-eighths interest in and to the following described oil and gas mining leases and all the right, title and interest of the original lessee and the present owners in and to said leases and leasehold estates, together with all such producing wells as are now upon the lands covered by said leases, all oil in storage thereon, and all lease equipment, pipe, casing, fixtures, tanks, machinery, tools and all other personal property located thereon or used in connection therewith, said leases being described as follows:

A lease executed May 28, 1910, by William T. Berryhill to J. H. Anderson covering the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Twenty-nine (29) Township Seventeen (17) North, Range thirteen (13) east, in Tulsa County, Oklahoma.

A lease executed on June 21, 1916, by Theodore F. Berryhill to Almar Oil & Gas Company, covering the North Half (N $\frac{1}{2}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ); the Northwest Quarter (NW $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) and the Southwest Quarter (SW $\frac{1}{4}$ ) of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section twenty-nine (29), Township Seventeen (17) North, Range thirteen (13) east in Tulsa County, Oklahoma.

A lease executed August 17, 1916, by R. L. Cummings to C. E. E. Thompson covering the Northeast Quarter (NE $\frac{1}{4}$ ) of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section twenty-nine (29), township seventeen (17) north, range thirteen (13) east, in Tulsa County.

TO HAVE AND TO HOLD the above described leases, and each of them, and the leasehold estates created thereby, to the said E. A. Bradley, Annie Bradley, and A. E. Bradley, their heirs, representatives and assigns in the proportions as above set forth, for and during the rest, residue and remainder of the term of said leases, and

TO HAVE AND TO HOLD The personal property above described to the said E. A. Bradley, Annie Bradley and A. E. Bradley, their heirs, representatives and assigns in the proportions above set forth, forever, for the same consideration the said Alf G. Heggem and M. E. Davis, for themselves, their successors and assigns, covenant that they have not heretofore assigned the right to drill for and take oil from the lands above described; that they have a good and valid title to said leases and to said lease equipment and personal property, and that the same are free and clear of all liens, incumbrances and indebtedness, and that all rentals and royalties due and payable
