## EASEMENT AGREEMENT.

This Agreement Made and entered into this the 17th day of November, by and between G.I. Hopson party of the first part, and John S. Zink, party of the second part.

WITNESSETH: Whereas the party of the first part is the owner of all of Lots 11, 12, and 13 in Block 23, Irving Place Addition to the city of Tulsa Tulsa County Oklahoma and whereas he has agreed to sell and convey unto the party of the second part, the west ninety (90) feet of said lots and whereas the party of the second part is desirous of building dwellings on said Ninety feet and whereas the sewer line runs north and south on the east end of said lots and whereas in order for the second party to connect with said sewer it is necessary for him to dig ditches across the East fifty (50) feet of said lots.

Hopson do for myself my heirs and assigns do hereby grant unto the second party his heirs or assigns easements and right of-way for the privilege of digging two ditches and laying lines therein across said East fifty (50) feet to said sewer line.
