for the purpose of permitting the City of Tulsa, to construct a sewer line thereto, through over, under and across said property, together with all necessary and convenient appurtenances thereto; and to use and maintain the same and of affording the city of Tulsa, its officers, agents employees and all persons under contract with it, the right to enter upon said premises and strip of land for the purpose of surveying excavating, for, laying constructing, operating, repairing, relaying and maintaining said sewer line anf for the further purpose of enabling the City of Tulsa, to do any and all necessary and convenient things, incident to such construction, operation, repairing and maintaining of such sewer line.

TO HAVE AND TO HOLD such easement and right of way unto the City of Tulsa, its successors or assigns forever.
