217035 GH COMPARED FARM RENTAL CONTRACT.

This Agreement, Made and entered into this 20th day of Dec. 1922 by and between
Thomas Hickory of -- party of the first part, and John T. Miller of Tulsa, Okla.
party of the second part.

WITNESSETH: That for and in consideration of the covenants and agreements herein-
after made, the party of the first part has let, leased and demised and does by these
presents let lease and demise unto the party of the second part for Agricultural
purposes, from and after the 26th day of Nov. 1923 to December 20, 1927 the following
described tracts of land lying in Tulsa County, State of Oklahoma:

SE $\frac{1}{4}$ of SW $\frac{1}{4}$ and SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sect. 7 Twp 17 N. Range
14 E. and NE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Sect. 8 Twp 17 Range 14 East containing
120 acres.

The said party of the second part, for the use of said land, agrees to pay to the
party of the first part, as rent the sum of One Hundred Fifty & no/100 dollars per
annum during the term of this contract, payable as follows:

Balance due in payments on Jan. 1st and on July 1st each year thereafter the
lease is in effect and party of the second part is in peaceable possession.
