ORDINANCE ADDING TO THE CITY OF SAND EPRINGS, OKLAHOMA A CERTAIN TRACT OF LAND KNOWN AS CAK RIDGE SECOND ADDITION TO THE CITY. OF SAND SPRINGS ADDING SAID TERRITORY TO WARD NO 2. ABD DECLARING AN EMERGENCY.

WHEREAS, the real estate and premises known as Oak midge second Addition to the city of Sand Springs Tulsa County, Oklahoma, according to the recorded plat thereof, and which is more particularly hereinafter described, is lying and situate adjacent to the City limits of the City of Sand Springs, Oklahoma.
