and Certificate Numer 820 being for  $9\frac{1}{2}$  share of "D" Stock in the Central Savings and Loan Association of Marshall Missouri, and possession of said premises and said shares of stock is now delivered into the said party of the second part.

TO HAVE AND TO HOLD the same with all the rights and appurtenances thereto belonging, to the said party of the second part and to his successors hereinafter designated, and to the assigns of him and his successor, forever.
