207913 C. J. COMPARED CONTRACT.

THIS AGREEMENT, made and entered into this 2nd day of September, 1922 by and between Emma Davis, Muskogee, Oklahoma, party of the first part, and Pearl B. Perryman Muskogee, Oklahoma, party of the second part:

WITNESSETH, that the said Emma Davis, in consideration of the agreement of the party of the second part hereinafter contained, contracts and agrees to and with the said Pearl B. Perryman, that Emma Davis agrees and contracts to give one-half (1/2) the gross proceeds of either all, or any one of the items of land, products, or moneys recovered by law suit or settlement which may result against the N 1/2 of the NW 1/4, and the S 1/2 of the NE 1/4 of Section 11, Township 19, and Range 11, in Tulsa County, Okla., to the said Pearl B. Perryman for the services hereinafter stated.

And the said Pearl B. Perryman agrees and contracts to use all legal and fair means to redeem, recover, or collect all or such parts of the lands, products, or moneys accruing from or belong to the above described real estate, in Tulsa County, Okla., which lands were originally allotted to the said Emma Davis by the Government.

The one-half (1/2) payment of such recovery shall be due to said Pearl B. Perryman upon receipt of the reimbursement of said lands, products, and moneys, to the said Emma Davis.
