

203007, D. J. COMPARED QUIT CLAIM DEED

An undivided one-third ( $1/3$ ) of all my undivided three-eighths ( $3/8$ ) interest in and to the allotment of Helen Hardridge, deceased, more particularly described as follows, to-wit:
