THIS INDENTURE, Made and entered into this 23rd day of August, 1922, by and between M. Ellis party of the first part, and THE EXCHANGE NATIONAL BANK, of Tulsa, Oklahoma, a corporation, party of the second part.

WITNESSETH: THAT WHEREAS, The party of the first part is the owner of a valid, existing and indefeasible oil and gas mining lease, free and clear of all liens and encumbrances, dated November 1st, 1910, executed by Susan E. Wilson and husband, W. M. Wilson, to Robert E. Jordan, and recorded in Book 98, page 651 of the records of the Register of Deeds of Tulsa County, Oklahoma, covering the following described property, located in Tulsa County, State of Oklahoma, to-wit:
