THIS INDENTURE, Made the 31st day of July, 1922, at Tulsa, Tulsa County, State of Oklahoma, by and between Mabel Garrett, the duly appointed, qualified and acting guardian of Eva Garrett, Ershel Garrett, Edith Garrett, T. J. Garrett, and Edmond Garrett Minors, party of the first part, and Ollie Borthick, the party of the second part

WITNESSETH, That Whereas, on the 21st day of June, 1922 the County Court within and for the County of Tulsa, State of Oklahoma, made an Order of Sale, authorizing the said party of the first part to sell certain real estate of the said Minors above named situated in the County of Tulsa, State of Oklahoma, described in said order of sale

AND WHEREAS, Under and by virtue of said Order of Sale and pursuant to legal notices given thereof, the said party of the first part, on the 7th day of July, A. D. nineteen hundred and 22, sold the hereinafter described real estate specified and described in said Order of Sale, subject to confirmation by said Court, for the sum of Eighteen Hundred and 00/100 Dollars, to her, being the highest and best bidder, and that being the highest and best sum bid.
