This Indenture, Made the 28th day of September A. D. 1922 between LUTIE L. HURST AND LEE A. HURST (wife and husband) of Tulsa of the County and State afore-said , as parties of the first part, and THE GEORGIA STATE SAVINGS ASSOCIATION OF SAVANNAH, a corporation duly chartered under the laws of the State of Georgia, and having its principal office and place of business in the City of Savannah, Chatham County, Georgia, as party of the second part.

WITNESSETH, That the said parties of the firstpart have mortgaged and hereby mortgage to the said second party, its successors and assigns, the following described real estate and premises, situate in the County of Tulsa , State of Oklahoma, to-wit:

All of Lot Number Nine (9) and the Easterly half ($\frac{1}{2}$) of Lot number Eight (8), in Block Two (2) , in the original Townsite of Tulsa, Tulsa County, Oklahoma expressly subject, however, to that certain mortgage from Lee A. Hurst and Lutie L. Hurst to said party of the second part, dated September 26, 1919 and recorded in the office of the County Clerk of Tulsa County, Oklahoma, in Mortgage Book 222, page 367;

with all the improvements thereon and appurtenances thereunto belonging, and warrant the title to the same.

This mortgage is given to secure a loan of Sixteen Thousand (\$16,000.00) Dollars this day made by said party of the second part to said parties of the first part, evidenced by the note and contract or obligation of said LUTIE L. HURST AND LEE A. HURST of even date herewith, conditioned to pay said Association on or before the last business day of each and every month until eighty-four (84) monthly payments have fallen due and been paid, the sum of Two Hundred, Fifty-six & 96/100 (\$256.96) Dollars (which is made up of the sum of One Hundred Ninety & 40/100 (\$190.40) Dollars as installments of principal , and Sixty-six & 56/100 (\$66.56) Dollars as installments of interest upon said loan), and to secure all other covenants and conditions in said note and contract set forth, reference to the same being hereby expressly made.

It is expressly agreed and understood by and between the said parties hereto that this mortgage is a first lien upon said premises, that the said parties of the first part will pay the said installments of principal and interest when the same fall due and at the place and in the manner provided in said note and contract, and will pay
