That for and in consideration of the sum of TWO HUNDRED andFIFTY (\$250.00) pollars, in hand paid, the receipt whereof is hereby acknowledged by the part y of the second part as having been this date received from Tulsa County, does hereby release said Tulsa County from any past future damages by reason of a certain drainage way traversing along by and through the following described lands, VIZ:
