The North Eighty (80) feet of Lot one (1) in Block Seven (7) Central Park Place addition to the City of Tulsa, Oklahoma, according to the recorded plat thereof.

in which conveyance appeared restrictions in the words following:

" And this conveyance is made by the Grantor and accepted by the grantee with the express understanding, covenant and agreement to run with the land hereby conveyed, for a period of ten years from the date hereof, that no building shall be erected on said land to be used as an apartment house or for any use or purpose other than a dwelling house:

and whereas the undersigned is informed that there has been built on said premises, since the date of her said deed; what is commonly known as a duplex dwelling house; Now therefore I hereby consent to the erection of said duplex dwelling house, any restrictions above mentioned to the contrary not withstanding, and that said restriction as to these premises are hereby waived.
