An absolute title in fee simple in and to the South-east Quarter of Section 1, the South-east quarter of Section 14, and the East Half of the North-west Quarter, the North-east Quarter of the South-west Quarter and the South-west Quarter of the North-east Quarter of Section 14, all in Township 25, North, Range 21, W.I.M., in Harper County, and Lots 17,19, 20,21 and 22 in Block 28, in the townsite of West Tulsa, Tulsa County, State of Oklahoma, according to the official plat of survey thereof in the office of the County Clerk of Tulsa County, Oklahoma,

And it further appearing to the court that the following persons are the sole and only heirs of said decedent and as such are entitled to distributive shares in said estate in the following proportions, to-wit:
