The units hereinabove specifically described, mentioned and referred to shall, from the date of the issuance hereof, entitle the aforesaid subscriber and owner to participate in the affairs of the said company to the same extent and on equal footing with other owners and holders of the units of this company, PROVIDED, HOWEVER, that the dividends or earnings on said units shall not be paid to the said owner until the delivery of the certificates representing said units according to the terms of these articles, but when a dividend on the units of beneficial interest in the said trust estate of this company shall be declared upon and ascribed to the remaining thirty-seven thousand, five hundred (37,500) units, said dividends shall be set apart and held in trust by said trustees for the use and benefit of the aforesaid owner and shall be paid the said owner by the said trustees upon the delivery of said certificates as aforesaid and shall be delivered at the time and in the manner as hereinbefore set out.
