ORDER APPROVING FULL BLOOD DEED.

Now on this the 23 day of September, 1922, there coming on for hearing the petition of Alex Carr, No. 1450, Nancy Simmons No. 1457, Ben B. Haikey, 950 and Kizzie Loler, No. 851, all full blood Creek Indians, and heirs at law of Hepsey Thompson, deceased Creek, Indian No. 1634, who was a full blood Creek, Indian, and all of said petitioners appearing in person and by their attorneys, and the court having heard the proof introduced in said matter and being full advised finds:

That all of the petitioners as well as the deceased Hepsey Thompson are enrolled on the approved Creek Indian rolls, as full blood Creek Indians, that said petitioners have filed herein their joint petition asking the court to approve a certain deed dated the 23 day of September, 1922, conveying all their undivided interest in and to the following described tract of land in Tulsa County, State of Oklahoma, to-wit:

The East Half of Section 16, Township 16 North, Range 13 East, containing 320 acres more or less,

to Perry McKay and Albert Turinsky for the total sum of \$800.00 and which deed is this day tendered in open court for approval.

The court further finds that the estate of Hepsey Thompson has been administered upon and that an adjudication has been had in this court determining who are her legal heirs and that said adjudication has been adverse to these petitioners and that an appeal is now pending in the Supreme Court involving the same, and that an agreement has been had whereby these petitioners are selling all their interest as above set out to said Perry McKay and Albert Turinsky they being the owners of substantially all the other interests, to the end that said litigation may be settled.

The court further finds that under all the circumstances the consideration is adequate and that said deed should be approved.

It is therefore ordered, adjudged and decreed by the court that said deed herewith tendered be and the same is hereby approved according to an act of Congress approved May 27th 1908, public No. 140.
