case may be, and in event that recovery is on land the first party hereby agrees to convey by proper conveyance an undivided one half interest in and to all lands recovered, to the party of the second part, immediately on final determination of the controversy concerning said lands. The party of the first part hereby grants unto said party of the second part, a lien in and to said first party's right, equity, interest, lands, rents, royalties profits and to all actions, judgments, settlements, or compromises arising therefrom to secure to second party, his agreed compensation for services, counsel and advise.

In consideration whereof the said party of the second part hereby accepts the employment and hereby agrees to faithfully and to the best of his ability prosecute all of the said first party's claim, demand, and suit in the premises to a final determination, at first party's cost, acting at all times and in accordance with his duties as attorney at law in the State of Oklahoma.
