And the Court further orders that the order for temporary alimony, heretofore issued herein, to-wit: on the 20th day of September, 1911, ordering plaintiff
to pay Fifty Dollars per month as temporary alimony to the defendant during the pendency of this action, and One Hundred Dollars attorney's fees to her attorneys be the
same is hereby set aside, annulled and held for naught, and it is further ordered that
the defendant have no claim upon or interest in or claim upon any property of the defendant; and it is further ordered by the Court that this decree do not become absolute
and take effect until six months from the date hereof, except as to all property rights
of the parties.
