NOW, THEREFORE, for and in consideration of the sum of One Dollar and other good and valuable considerations, and in consideration of the Massachusetts Mutual Life Insurance Company, of Springfield, Massachusetts, loaning to the said Boston Avenue Methodist Episcopal Church, South, the sum of Forty-eight Thousand (\$48,000.00) Dollars, the said Board of Church Extension of the Methodist Episcopal Church, South, of the City of Louisville, Kentucky, hereby agrees to waive its right to a prior lien upon said above described property by reason of its said mortgage and refunding bond, which was filed on April 2, 1912, and recorded in Book 125, page 33 of the records of the Register of Deeds of Tulsa County, Oklahoma, and consents and agrees that the mortgage made by the Board of Trustees of the Boston Avenue Methodist Episcopal Church, South of Tulsa, Oklahoma, to the Massachusetts Mutual Life Insurance Company, of Springfield, Massachusetts, shall be a first and prior lien covering said above described property, and consents and agrees that its said mortgage and refunding bond so filed on April 2, 1912, shall be inferior and subordinate to the mortgage lien of the Massachusetts Mutual Life Insurance Company, of Springfield, Massachusetts, in the sum of Forty Eight Thousand (\$48,000.00) Dollars, and said Board of Church Extension of the Methodist Episcopal Church, South, of the city of Louisville, Kentucky, also agrees and consents that the mortgage made by the Boston Avenue Methodist Episcopal Church, South, of Tulsa, Oklahoma, to Exchange Trust Company, of Tulsa, Oklahoma, in the sum of Twenty Four Hundred (\$2400.00) Dollars shall be superior to the lien of said Board of Church Extension of the Methodist Episcopal Church, South, of the City of Louisville, Kentucky, and agrees that its lien of Three Thousand (\$3000.00) Dollars shall be inferior and subordinate to the mortgage lien of the Exchange Trust Company, in the sum of Twenty Four Hundred (\$2400.00) Dollars.
