A strip of ground, as shown by the blue prints on file in the City Engineer's office of the City of Tulsa, said strip, being more particularly described as follows,

> Twenty five (25) feet off the South Mast corner of Lot 6, Block 1, Stutsman Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof.

for the purpose of permitting the City of Tulsa to construct a sewer line thereto, through, over, under and across said property, together with all necessary and convenient appurtenances thereto; and to use and maintain the same, and of affording the City of Tulsa, its officers, agents, employees, and all persons under contract with it, the right to enter upon said premises and strip of land for the purpose of surveying. excavating for, laying, constructing, operating, repairing, relaying and maintaining said sewer line and for the further purpose of enabling the City of Tulsa, to do any and all nocessary and convenient things, incident to such construction, operation, repairing, and maintaining of such sewer line.
