THIS INDENTURE, Made this 23rd day of November A.D. 1922 between Clarence L. Lloyd, a single man, party of the first part, and David H. Vire party of the second part.

WITNESSETH, That said party of the first part in consideration of the sum of One Dollar and other good and valuable consideration to me duly paid, the receipt of which is hereby acknowledged has quit claimed, granted, bargained, sold and conveyed, and by these presents do for myself my heirs, executors and administrators, quit claim, grant, bargain, sell and convey unto the said party of the second part and to his heirs and assigns, forever, all of my right, title, interest, estate -- claim and demand both at law and equity in and to all the following described property, to-wit:
