That the undersigned, the owner of the legal and equitable title to the following described real estate, situated in Tulsa County, State of Oklahoma, for and in consideration of the sum of One Dollar (\$1.00) cash in hand, paid by the city of Tulsa, Oklahoma, and other good and valuable considerations, receipt of which are hereby acknowledged, does hereby grant and convey unto the said City of Tulsa, Oklahoma, a perpetual easement, through, over, under and across the following described property situated in said Tulsa County, to-wit:

A strip of land fifty (50') feet wide, being the north fifty (50') feet of West Half (W 1/2) of Southeast Quarter (SE*) of Southeast Quarter (SE 1) of Section Right (8). Township Twenty (20) North, Range Thirteen (13) Bast, beginning at the northeast corner of the West Half (W2) of the Southeast Quarter (SE 1) of Southeast Quarter (SE 1) of Section Eight (8), Township Twenty (20) North, Range Thirteen (13) East, thence west six hundred sixty (660') feet, thence south fifty (50') feet, thence east six hundred sixty (660') feet, thence north fifty (50') feet to the point of beginning, containing seventy six hundredths (0.76) acre more or less, all in Tulsa County.
