AGRICULTURAL LEASE.

THIS CONTRACT, Made and entered into this 11th day of December, A.D. 1922, by and between Walter Anderson, P.O. Sapulpa, Oklahoma, a citizen of the Creek Nation, Roll No. 2118, as lessor and Sallie Morrison P.O. Broken, Arrow, Oklahoma, as lessee,

WITNESSETH: That for and in consideration of the rents, covenants, and agreements hereinafter provided, on the part of the lessee to be paid and performed, the lessor doth hereby let and lease unto the said lessee the following described land and premises located in Tulsa County, Oklahoma:

Northwest quarter of the Southeast quarter
Section 33, Tp. 19 N. R. 11 E., and containing 40 acres, more or less, for the period beginning on the 1st day of January, 1923, fully to be completed and ended on the 31st day of December, 1923, subject to the conditions hereinafter provided for.

The said lessee in consideration of said premises as above set forth, covenant and agree with the lessor to pay said lessor as rental for the same, the sum of seventy five Dollars (\$75.00), being at the rate of seventy five Dollars (\$75.00) per annum, payable as follows, to-wit: Twenty five dollars cash in hand and fifty dollars on January 1st 1923.

For the ~~acre~~^{grass} or pasture land, of which there are -- acres, the said lessee agrees to pay for the use thereof a cash rental of -- (\$--) per acre, to the lessor.

The lessee agree to break out and place in a state of cultivation -- acres of said land now in cultivation before the -- day of -- 191- and further covenant and agree- that he will, at -- own expense, within -- from the date hereof, build, construct and erect the following improvements upon the above described land: - - -

all of which are to be constructed in a substantial and workmanlike manner and of durable material.

The less - agree- to keep said premises in good repair; to work and farm said premises in a good husbandlike manner, to commit no waste thereon; to not alter said premises except as may be herein provided; to at all times plow and tend said premises
