Beginning at a point on the North line of Lot 6, Block 10, Norvell Park Addition to the City of Tulsa, Oklahoma, 28 feet East of the Northwest corner of said Lot; thence Southwesterly to a point on the South line of said Lot, 28 feet East of the Southwest corner of said Lot.

for the purpose of permitting the City of Tulsa to construct a sewer line thereto, through, over, under and across said property, together with all necessary and convenient appurtenances thereto; and to use and maintain the same, and of affording the City of Tulsa, its officers, agents, employees and all persons under contract with it, the right to enter upon said premises and strip of land for the purpose of surveying, excavating for, laying, constructing, operating, repairing, relaying and maintaining said sewer line and for the further purpose of enabling the City of Tulsa, to do any and all necessary and convenient things, incident to such construction, operation, repairing, and maintaining of such sewer line.
