And for the same consideration. Harvey Crude Ctl Company covenants that it has not heretofore sold or conveyed the right to drill for and take oil from said lands; that it has a good and marketable title to said leases, and to the lease equipment and personal property herein conveyed, and that said leases and property are free and clear of all liens and encumbrances, and that all rents and royalties due and payable under said lesses have been duly paid.
