CONTRACT.

STATE OF OKLAHOMA,)
COUNTY OF TULSA.)

This contract and agreement made and entered into this the 5th day of December, 1922 by and between L. J. Williams of Tulsa County, Oklahoma, party of the first part and J. G. Hollis and P. H. Gallagher of the same state and county parties of the second part, witnesseth:

THAT WHEREAS the party of the first part is now the equitable owner of a large block of acreage of oil and gas mining leases, among which is the lands herein-after described, and which said party will not receive his assignments and the legal title thereto until he has commenced drilling operations on said block:

AND WHEREAS the party of the first part has this day sold to the parties of the second part a forty acre lease out of said tract and the parties of the second part have paid him the consideration therefor;

NOW THEREFORE in consideration of the premises and the further sum of one dollar and other good and valuable considerations in hand paid to the part of the first part the receipt whereof is hereby acknowledged, the party of the first part hereto hereby contracts and agrees in writing to execute and deliver to the parties of the second part a good and valid assignment of a regular commercial oil and gas mining lease on the following lands located in Tulsa County, Oklahoma, to-wit:

The NW¹ of the NW¹ of Section 36 in Township 18 North, of Range 13 East. Said assignment to be made as soon after the commencing of the well on the tract of lands aforesaid and the receipt of the title to said leases by the party of the first part, as may be convenient to the parties hereto.

This contract shall be binding upon the parties hereto their heirs, assigns, administrators and executors.
