It is further stipulated, agreed and understood that the part of the second party his heirs, executors, administrators or assigns, shall never sell, convey, transfer, lease or rent any of the above described property to a North or any one of Negro descent. This is a limitation running with the land and is hereby accepted as such.

If the party of the second part his heirs, executors, administrators or as assigns shall violate any of the restrictions in this deed in any way, either the grantors herein or any owner of any real estate in East Highland, an addition to the City of Tulsa, Tulsa County, Okla. may enforce said restrictions in any court of competent jurisdiction either by suit for injunction or to recover damages.
