THIS INDENTURE, Made this 9th day of May A. D. 1922, between O. S. HOPPING, Sr., and SUSIE HOPPING, his wife, of the first part, and M. J. McNULTY, party of the second part.

WITNESSETH, That said parties of the first part in consideration of the sum of One and 00/100 (\$1.00) DOLLARS, to them duly paid, the receipt whereof is hereby acknowledged, have remised, released, and quit-claimed, and by these presents do for themselves, their heirs, executors and administrators, remise, release, and forever quit-claim unto the said party of the second part, and to his heirs and assigns, forever, all their right, title, interest, estate, claim and demand, both at law and in equity, of, in and to all the following described real property and premises, situate in Tulsa County State of Oklahoma, to-wit:

Beginning at a point 360 feet South of the Northeast Corner of the Northwest Quarter (NW $\frac{1}{4}$) of Section Seven (7), Township Nineteen (19) North, Range Thirteen (13) East; thence West 434 feet; thence South 360 feet; thence West 140 feet; thence south 450 feet; thence East 574 feet; thence North 450 feet; thence West 140 feet; thence North 50 feet; thence East 140 feet; thence North 310 feet to place of beginning.
