## COMPARED

RELEASE OF MORTGAGE  
( Corporation Form)

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, on the 30th day of June 1920 a certain mortgage was executed by Eugene Wilson and Mattie Wilson, his wife, mortgagors to United Savings & Loan Association mortgagee for the sum of Fifteen Hundred DOLLARS upon the following described real estate, viz:

A part of Lot Two, Block-Twenty-two, in the Town of North Tulsa, Tulsa County, Oklahoma, according to the approved plat thereof, recorded and described as follows, to-wit:

Beginning at a point in the Easterly line of said lot a distance of twenty-five feet Southerly from the Northeast Corner thereof; thence along the Easterly line in a Southerly direction a distance of fifty feet; thence in a Westerly direction at right angles to the Easterly line of said lot, a distance of sixty feet to the line dividing the Creek Nation from the Cherokee Nation, thence in a Westerly direction following the said dividing line to the Westerly boundary of said lot, being a point in the Easterly line of the alley running through the said Block, thence in a Northerly direction along said alley line a distance of Sixteen and four-tenths feet; thence at right angles in an Easterly direction one hundred forty feet to the place of beginning, Also a part of Lot One, Block Twenty-two in the Town of Tulsa, Tulsa

County, Oklahoma, according to the approved plat thereof, recorded and described as follows, to-wit: Beginning at a point in the Westerly line of said lot at a distance of thirty-four feet in a Southerly direction from the Northwest corner thereof, thence in an EASTERLY direction at right angles to said Westerly line of said lot a distance of eighty feet to the line dividing the Creek Nation from the Cherokee Nation; thence in a Westerly direction following the said dividing line to the Northwest corner of said lot; thence in a southerly direction along the Westerly lines of said lot a distance of thirty-four feet to the place of beginning.
