 Oklahoma, party of the second part.

WITNESSETH, That for and in consideration of the covenants and agreements  
 hereinafter made, the party of the first part has let, leased and demised, and does by  
 these presents let, lease, and demise unto the party of the second part, for agricultural  
 purposes, for the term of (5) five years from and after the 31st day of Oct. 1922, the  
 following described tracts of land lying in Tulsa County, state of Oklahoma:

W 2 of SE 4; & SE 4 of SW 4 Section 7, Township 19 N. North, Range 11 East

The said party of the second part, for the use of said land, agrees to pay  
 to the party of the first part, as rent One Hundred Sixty and no/100 DOLLARS per annum
