TO HAVE AND TO HOLD the said plant site lease unto the said G. W. Shimeall, Trustee, during the entire term thereof, subject, however, to all terms and conditions therein contained; and to have and to hold the said gasoline plant, together with the equipment thereto connected unto the said G. W. Shimeall, Trustee, his heirs, assigns or legal representatives forever, free, clear and unincumbered; and I hereby warrant the title to the same.
