213973 C. J. CONTRACT FOR DEED

THIS AGREEMENT made and entered into this 8th day of August, 1922, by and between Bridget P. Fitzpatrick, a widow, party of the first part, and Edward Fitzman, party of the second part, both of Tulsa, Oklahoma.,

WITNESSETH THAT:

1. That party of the first part is the owner of the following described premises situate in Tulsa County, State of Oklahoma, to-wit:

Lot 12, Block (2), George Perryman Addition to the City of Tulsa, according to the recorded plat thereof.

2. That party of the first part desires to sell and party of the second part to purchase said premises.

3. That said party of the second part agrees to purchase said premises and said party of the first part agrees to sell said premises for the sum of \$5,625.00 together with interest thereon as hereinafter specified.

4. That said sum of \$5,625.00 shall be paid by said party of the second part to said party of the first part as follows:

Five Hundred (\$500.00) Dollars upon the signing of this contract. The balance in monthly installments, beginning September 1st, 1922, said monthly installments shall be \$50.00 each and shall be placed to the credit of party of the first part at the CENTRAL NATIONAL BANK OF TULSA, OKLAHOMA, on or before the tenth day of the month when any particular payment shall accrue and be payable.
