	WIINESSETH: That the said lessor, for and in consideration of Eighty and No/100
	Dollars, cash in hand paid, the receipt of which is hereby acknowledged, and of the
	covenants and agreements hereinafter contained on part of lessee to be paid, kept and
	performed, has granted, demised, leased and let and by these presents does grant, demise,

lease and let unto the said lessee for the sole and only purpose of mining and operating for oil and gas and of laying of pipe lines , and of building tanks, powers, stations and structures thereon to produce , save and take care of said products, all that certain tract of land situate in the County of Tulsa State of Okla. described as follows, to-wit: The North East quarter of the South East quarterof Section 16 Township 18 N Range 13 E and containing 40 acres, more or less. It is agreed that this lease shall remain in force for a term of six months from this date, and as long thereafter as oil or gas or either of them is produced from said land by lessee on the said premises are developed or operated by the lessee .

In consideration of the premises the said lessee covenants and agrees:

lst. To deliver to the credit of lessor, free of cost, in the pipe line to which they may connect their wells, the equal one-eighth part of all oil produced and saved from the leased premises.

2nd. To pay lessor 1/8 of the gas sold for the gas from each well where gas only is found, while the same is being used off the premises, and if used in the manufacture of gasoline or any other product, a royalty of one-eighth (1/8), payable monthly at the prevailing market rate; and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making their own connections with the well at their own risk and expense.

3rd. To pay lessor for gas produced from any oil well and used off the premises or in the manufacture of gasoline or any other product at the rate of 1/8 of the gas sold for the time during which such gas shall be used, payable monthly or a royalty of one eighth (1/8) payable monthly at the prevailing market rate.

If no well be commenced on said land on or before the 16 day of <sup>14</sup>arch 1923, this lease shall terminate as to both parties, unless the lessee shall on or before that date pay or tender to the lessor or to the lessor's credit in the lat State Bank at Jenks Ok. or its successors, which shall continue as the depository regardless of changes in the ownership of said land, the sum of ----- Dolkrs, which shall operate as a rental and cover the privilege of deferring the commencement of a well for -----months from said date. In like manner and upon like payments or tenders the commencement of a well may be further deferred for like periods of the same number of months successively. And it is understood and agreed that the consideration first recited herein, the down payment, covers not only the privilege granted to the date when said first rental is payable as aforesaid, but also the lessee's option of extending that period as aforesaid, and any and all other rights conferred.

Should the first well drilled on the above described land be a dry hole, then, and in that event, if a second well is not commenced on said land within twelve months
