REAL ESTATE MORTGAGE EXTENSION

We, the undersigned, do hereby covenant that I am the legal owners of the Northerly Fifty feet (N 50') of Lot Five (5), in Block One Hundred Twenty-four (124) in the city of Tulsa, in Tulsa County, Oklahoma, the same being the premises conveyed to M. L. Little by a certain real estate mortgage dated November 6, 1920 made by Harry V. Meathers & wife, Charlotta May Meathers which mortgage is recorded in Book 365 page 100 in the Register's of deeds office in Tulsa County, Oklahoma; said mortgage was given to secure the payment of a certain promissory note for the sum of \$3500.00 payable November 6, 1922, such note payable to the order of M. L. Little, upon which note there remains unpaid the sum of \$3500.00 as principal money.

In consideration of the extension of the time for the payment thereof, for the term of Two years from maturity we hereby agree to pay interest on said principal sum as yet unpaid, from the day whereon the same, by the terms of the said note become due, at the rate of 8 per cent per annum, payable semi-annually, for and during said term of extension according to the tenor and effect of the extension coupon notes this day executed.

Both principal and interest to be paid when due at the office of C. D. COGGESHALL & CO. in Tulsa, Oklahoma, and in case of default in the payment of any of said extension coupons, or in case of non-payment of taxes or insurance or the breach of any of the covenants contained in the original real estate mortgage, it shall be optional with the holder of said mortgage to declare said principal sum immediately due and payable.
