GAS LEASE

AGREEMENT, Made and entered into the 20th day of November ,1922 by and between Pavid H. Vire, & Ella Jane Vire, his wife, of Tulsa, Oklahoma hereinafter called lessor (whether one or more), and Sam Kornfeld, of Tulsa, Oklahoma, hereinafter called lessee:

WITHERSETH: That the said lessor, for and in consideration of one pollars, cash in hand paid, the roceipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does grant, demise, lesse and let unto the said lessee for the sole and only purpose of mining and operating for oil and gas and of laying of pipe lines, and of building tanks, powers, stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the COUNTY of Tulsa, State of Oklahoma, described as follows, to-wit:

The Southeast quarter (SEL) of the Northeast quarter (NEL) of Section 29 Township 20 North Range 13 East, & containing 40 acres, more or less.

It is agreed by the parties hereto, that the lessee shall commence a well, on or before Feb. 1, 1923, on the above described tract of land; said well is to be drilled to the Wilcox sand, not exceeding a depth of 1850, unless oil or gas is found in paying quantities at a lesser depth.

It is understood by the parties hereto, that this lease applies only to the gas rights; also, that this lease replaces all previous leases, executed by the lessors, for the same tract of land.

It is agreed that this lease shall remain in force for a term of Five years from this date, and as long thereafter as oil or gas or either of them is produced from said land by lessee.

In consideration of the premises the said lessee covenants and agrees:

2nd. To pay lessor for the gas from each well where gas only is found, while the same is being used off the premises and if used in the manufacture of gasoline or any other product, a royalty of one-eighth (1/8), payable monthly at the prevailing market rate; nd lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and expense,

3rd. To pay lessor for gas produced from any oil or gas well and used off the premises or in the manufacture of gasoline or any other product of a royalty of one-eight (1/8) payable monthly at the prevailing market rate.

If no well be commenced on said land on or before the lat day of Peburary 1923, this leads shall terminate as to both parties, unless the lesses shall on or before that date pay or tender to the lessor or to the lessor's credit in the Central National Bank at Tulsa, Oklahoma, or its successors, which shall continue as the depository regardless of changes in the example of said land, the sum of yorty pollars, which shall operate as a rental and cover the privilege of deferring the commencement of a well for greate months from said date.
