TO HAVE AND TO HOLD the said easements unto said THE TEXAS PIPE LINE COLPANY OF OKLAHOMA, its successors and assigns, so long as such structures are maintained.

And by the acceptance hereof the grantee agrees to bury such pipe lines so that they will not interfere with the cultivation of the land, and also to pay any all damages to crops, fences and land which may be suffered from the construction, operation or maintenance of such pipe lines.
