

Seventeen (17), Township Twenty-nine (29), Range Fourteen (14).

Also beginning at a point near the Center of the Southwest Quarter (SW $\frac{1}{4}$) of Section Seventeen (17), Township Twenty-nine (29), Range Fourteen (14); thence West to the West line of said Section Seventeen (17); thence South along said West line to the Southwest (SW) corner thereof; thence in a Westerly direction along the South line of Section Eighteen (18) to the Southeast (SE) corner of the Southeast Quarter (SE $\frac{1}{4}$) of said Section Eighteen (18); thence in a Southwesterly direction crossing the public high-way to a point being the Northeast (NE) corner of the Northwest Quarter (NW $\frac{1}{4}$) of Section Nineteen (19); thence in a Westerly direction to a point being about the Center of the Northwest Quarter (NW $\frac{1}{4}$) of Section Nineteen (19); thence in a Northwesterly direction crossing the public high-way to a point on the South side of Section Eighteen (18) at about the Center of the Southwest Quarter (SW $\frac{1}{4}$) thereof but along the South side of said Section; thence in a Westerly direction along the South line of Section Eighteen (18) to the Southwest (SW) corner thereof; thence crossing the public high-ways, being the range lines dividing Ranges Thirteen (13) and Fourteen (14) to a point in the Northeast (NE) corner of Section Twenty-four (24); thence continuing in a Westerly direction along the North side of Section Twenty-four (24), Township Twenty-nine (29), Range Thirteen (13), to the Northwest corner thereof, all being in Washington County, Oklahoma.

Also beginning at a point close to the Northwest (NW) corner of the Southeast Quarter (SE $\frac{1}{4}$) of Section Twenty-four (24), Township Twenty-two (22), Range Thirteen (13), Tulsa County, Oklahoma; thence North and Northwest through Section Twenty-four (24) and continuing in a Northwesterly direction to a point along the East line of Section thirteen (13) of said Township and Range; thence North along the East line of Sections Thirteen (13) and Twelve (12) in said Township and Range to a point where said line connects with the South Osage line running East and West at about the Center of the Northeast Quarter (NE $\frac{1}{4}$) of Section Twelve (12), Township Twenty-two (22), Range Thirteen (13) but along the East line thereof.

Also beginning at a point near the Northwest (NW) corner of Osage County in Section Two (2); thence in a Southeasterly direction through said Section Two (2) and Section Eleven (11) to a point connecting with what is known as the South Osage line, being the Center of the Northeast Quarter (NE $\frac{1}{4}$) of said Section Eleven (11); all in Township Twenty-two (22), Range Twelve (12) in Tulsa County, Oklahoma.

Also beginning at the county line dividing Tulsa and Osage Counties at about thirteen hundred forty-six feet (1346') South of the North line of Section Eleven (11); thence running Easterly through Sections Eleven (11) and Twelve (12), Township Twenty-two (22), Range Twelve (12), continuing Eastward through the North side of Sections Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11) and Twelve (12) of Township Twenty-two (22), Range Thirteen (13), to a point connecting with the main Sixteen-inch (16") No. 2 line hereinafter described, together with all lateral lines of every kind, character and description leading into and connecting therewith located on the West and South side of Section Eleven (11), Township Twenty-two (22), Range Thirteen (13).

Also a line in the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirty-five (35), Township Twenty-four (24), Range Thirteen (13), connecting the line in Osage County with the line in Tulsa County, Oklahoma.

Also beginning at about the Center of Section Thirty-one (31), Township Twenty-four (24), Range Thirteen (13), along the South side of said section; thence Easterly along the South side of Section Thirty-one (31), Thirty-two (32), Thirty-three (33), Thirty-four (34), and Thirty-five (35), and Thirty-six (36); all in Township Twenty-four
