Jones of Tulse, Okla., enrolled as a ½ blood citizen of the Creek Mation, Aoll Mo. 9574, party of the first part, hereinafter designated as lessor, and Posey R. Short of Tulsa, Oklahoma, party of the second part, hereinafter designated as lessee, under and in pursuance of the provisions of the Act of Congress approved May 27, 1908, (35 Stat. L. P. 312) WIT-

1. The lessor, for and in consideration of one dollar, the receipt whereof is acknowledged, and of the royalties, covenants, stipulations and conditions hereinafter contained, and hereby agreed to be paid, observed and performed by the lessee, does hereby demise, grant, lease, and let unto the lessee, for the term of ten years from the date of the approval hereof by the Secretary of the Interior, and as much longer thereafter as oil or gas is found in paying quantities, all the oil deposits and natural gas in or under the following described tract of land, lying and being within the county of Tulsa and State of Oklahoma, to-wit:

The West twenty one and eighteen hundredths (21.18) acres of Lot Two (2) of Section Three (3) Township Nineteen (19) North, Range Ewelve (12) East of the

Indian Meridian, and containing 21.18 acres, more or less, /ROYALTS NO.48162/ with the exclusive right to prospect for, extract, pipe, store and remove oil and natural gas, and to occupy and use so much, only of the surface of said land as may reasonable be necessary to carry on the work of prospecting for, extracting, piping, storing, and removing such oil and nautral gad, also the right to obtain from wells or other sources on said land by means of wine lines or otherwise, a sufficient supply of water to carry on said operations, and also the right to use, free of cost, oil and natural gas as fuel so far as necessary to the development and operation of said property. 2. The lessee hereby agrees to pay or cause to be paid to the Superintendent of the Five Civilized Tribes, Muskogee, Oklahoma, for the lessor, as royalty, the sum of 12% per cent. of the gross proceeds of all crude oil extracted from the said land, such payment to be made at the time of sale or removal of the oil. And the lessee small pay as royalty on each gas producing well three hundred dollars per annum in advance, to be calculated from the date of commencement of utilization: PROVILED, however, in the case of gas wells of small volume, when the rock pressure is one hundred pounds or less, the parties hereto may, subjest to the approval of the Secretary of the Interior, agree upon a royalty, which will become effective as a part of this lease; PROVIDED, FURTHER, That in case of gas wells of small volume, or where the wells produce both wil and gas or wil and gas and salt watter to such extent that the gas is unfit for ordinary domestic purposes, or where the gas from any well is desired for temporary use in connection with drilling and pumping operations on adjacent or nearby tracts, the lesses shall have the option of paying royalties upon such gas wells of the same persentage of the gross proceeds from the sale of gas from such sells as is raid under this lease for royalty on oil. The lessor shall have two free use of gas for demostic purposes in his residence on the leased premises, profided there shall be .urplus see produced on said premises over and above enough to fully AMERICAN SURETY CO.
