All sums secured by this mortgage shall be paid at the office of First National Bank, Tulsa Oklahoma, unless otherwise specified in the note.

It is expressly agreed and understood by and between the saidparties hereto, that this mortgage is affirst lien upon said premises; that the party of the first part will pay said principal and interest at the times when the same fall due and at the place and in the manner provided in said note, and will pay all taxes and assessments against said land when the same are due eah year, and will not commit or permit any waste upon said premises, that the buildings and other improvements thereon shall be kept in good repair and shall not be destroyed or removed without the consent of the second party, and shall be kept insured for the benefit of the second party or its assigns, against loss by fire or lightening for not less than Two thousand and no/100 dollars, in form nd in companies stisfactory to said second party, and that all policues and renewal receipts shall be delivered to said second party. If the title to the said premises be transferred, said second party is authorized, as agent of the firt party, to assign the insurance to the grantee of the title.

Party of the firt part and their heirs, executors, administrators and assigns, will warrant the quiet enjoyment of the aforesid premises to the sid party of the second part, his heirs, executors, administrators and assigns, and will forever defend the foresaid premises against the lawful claims and demands of all persons.

IT IS FURTHER AGREED AND UNDERSTOOD that the sad second party may pay any taxes and assessments levied against said premises or any other sum necessary to protect the rights of such party or its assigns, including insurance upon buildings, and recover the same from the first part with 10 per cent interest, and that every such payment is secured hreby, and that in case of a foreclosure hereof and as often as my foreclosure hereof may be filed, the holder hereof may recover from the first party an attorney fee of Two hundred dollars, or such different sum as may be provided for by said note, which shall be due upon the filing of the petitition in foreclosure and which is secured hereby, and which the first party promises and agrees to pay, together with expense of examintaion of title in preparation for foreclosure. Any expense incurred in litigation or otherwise, including attorney fees and abstract of title to said premises, incurred by reason of this matgage or to protect its liens, shall be repaid by the mortgager to the mortgage or assigns, with inteest thereon at 10 per cent per annum, and this mortgage shall stand as security therefor.

AND IT IS FURTHER AGREED that upon a breach of the warranty herein or upon a failure to pay when due any sum, interest or principal, secured hereby, or any tax or assesment herein mentioned, or to comply with any requirements herein, or upon any waste upon sid premises, or any removal or destruction of any building, or other improvements thereon, without the consent of the said econd party, the whole sum secured hereby shall at once and without notice become due and payable at the option of the holder thereof, ad shall be interest thereafter at the rate of 10 per cent per annum, and the sad party of the second part or its assigns shall be entitled to a foreclosure of this motgage and to have the premisessold and the proceeds applied to the payment of the sums secured hereby, and that immediately upon the filing of the petition in forclosure the holder hereof shall be entitled to the possession of the said prmises, and to collect and apply the rents thereof, less rasonable expenditure, to the payment of sad indettedness, and for this purpose the holder thereof shall be entitled to a receiver, to the appointment of which the mortgagors hereby consent, which appointment may be made either before or after the decree of foreclosure, and the holder hereof shall in no case be held to account for any rental or dmage other than for rents actually recived, and the appreciaement of said premises is here
