ORDER APPROVING DEED BY FULL BLOOD

## INDIAN HEIR

Now on this 14th day of September, 1922, the above cause coming on for hearing upon the verified petition of Pauline Chissoe, nee Chisholm, for the approval of a certain deed, made, executed and delivered by her to J. M. Winters, of Tulsa, Oklahoma, on the 14th day of September, 1922, and said petitioner appearing in person and by counsel, and the said cause being now submitted to the Court for its approval, the Court proceeded to hear the evidence produced in support of said petition and being fully advised in the premises, finds:

That the said Pauline Chissoe, the grantor and petitioner herein, was formerly Pauline Chisholm, and that she was joined in said petition and in said deed by her husband, W. F. Chissoe, and that said Pauline Chissoe, nee Chisholm, is a full blood Oreek Indian Citizen, duly enrolled as such on the Tribal Rolls of the Creek Nation, opposite Roll No. 9474: that Anderson Chisholm, deceased was a full blook Creek Indian Citizen, duly entolled as such on the Tribal Rolls of the Creek Nation, opposite Roll No. 844; that the said Anderson Chisholm died intestate, in Tulsa County, State of Oklahoma, and at the time of his death, was a bona fide resident of the said Tulsa County, State of Oklahoma.

That the County Court of Tulsa, County has jurisdiction to administer upon the estate of the said dededent, and has jurisdiction to approve a deed executed by his said heir, the petitioner herein,

That there was allotted to the said Anderson Chisholm, during his life time, as his proportionate part of his allotment of the Creek Nation, the following described land, to-wit:

> The north half  $(N_2^4)$  of the northwest quarter  $(NW_2^4)$  and the southeast quarter  $(SE_2^4)$  of the Northwest quarter  $(NW_2^4)$  of section 25, township 18 North, range 13 east, being his surplus allotment situated in Tulsa County, State of Oklahoma.

That the said Anderson Chisholm left surviving him at the time of his death, Rosa Chisholm, his wife, a duly enrolled Creek Indian citizen, entolled &pposite Roll No. 845, Pauline Chissoe, nee <sup>C</sup>hisholm, a daughter, a duly enrolled fall blood Creek Indian citizen, entolled opposite roll No. 9474, and who is the petitioner herein, Minnie Chisholm, a daughter, a duly enrolled full blood Creek Indian citizen, enrolled opposite Roll No. NB 443, and Lena Chisholm, a daughter, who is a full blood Creek Indian, but not enrolled, being born since March 4, 1906, all of whom are the said inderson Chisholm's sole and only heirs.

The court further finds that in accordance with an Act of Congress, approved june 14, 1918, the same being public No. 172, 65th Congress (S4151) conferring jurisdiction
