upon the District Court to partition land belonging to full blood Indian Heirs of allottees of the Five Civilized Tribes, and for other purposes, a decree was made and entered wherein and whereby the said surplus sablotment of the said Anderson Chisholm, decedent was partitioned among the suid heirs above named; that by proper decree of the District Court of Tulsa County, State of Oklahoma, the said Pauline Chissoe, nee Chisholm, received as her portion of the said allotment and there was set over to her, the following described lands, to-wit: 129

The north 26-2/3 acres of the northwest quarter (NW_{2}^{+}) of the northwest quarter (NW_{2}^{+}) of section 25, township 18 north, range 13 east, situated in Tulsa County, State of Oklahoma.

That the said Pauline Chissoe, nee Chisholm, joined therein by her husband, W. F. Chissoe, under date of the _____ day of September, 1922, made, executed and delivered er hertain deed to ^J. M. Winters, of ^Tulsa, Oklahoma, wherein and whereby she conveyed to the said ^J. M. Winters, the said land described as the North 26-2/3 acres of the Northwest quarter of the northwest quarter of section 25, township 18 north, range 13 east, situated in Tulsa County, State of Oklahoma.

The court further finds that the said transaction was, made for a valuable consideration and that the same is responsible, just and adequate and that the said faultur Tuitme Chissoe, nee Chisholm, is setisfied therewith and desires the court to approve same.

IT IS THEREFORE ORDERED ADJUDGED AND DECREED by the court that the said deed, dated the 14th day of September, 1922, made, delivered by the said Puline Chissoe, nee Chisholm, and joined therein by her husband, W. F. Chissoe, to the said J. M. Winters, covering the land therein described, be and the same is hereby in all things approved, ratified and confirmed.
