

SEAL AND CERTIFICATES

18. All certificates shall be signed by the President and Secretary and bear the seal of the Association. No assessment shall ever be made upon the shareholders, and the books of the Association shall always be open to their inspection. The Association shall have a seal and inscribed thereon shall be the name of the Association and also the word "Seal 1922".

ANNUAL ACCOUNT.

19. The trustees shall render an account annually or oftener, of convenient, and shall, upon request, deliver or mail a copy to each shareholder.

MAY PROVIDE SALARIES.

The trustees may provide for the payment of salaries, wages, fees and commissions to the officers, clerks, agents and other employees of the Association.
