Martin, her husband, of Tulsa County, Oklahoma, hereinafter called mortgagor, to secure the payment of the sum of Eight Hundred and no/100 dollars paid by the First Trust Company of Wichita, mortgagee, does hereby mortgage to said The First Trust Company of Wichita, the following described premises situated in the County of Tulsa, Oklahoma, to-wit:

The northeast quarter (NE $\frac{1}{4}$) of the northwest quarter (NW $\frac{1}{4}$) of section twenty three (23) township nineteen (19) north, range thirteen (13) east

of the Indian Meridian, containing in all 40 acres, more or less, according to Government survey, with all the appurtenances, and warrant the title to the same.

This mortgage is made to secure the payment of the money, and the performance of the agreements, to be paid and performed by mortgagor to-wit:
